

AMENDMENT TO MEMORANDUM OF UNDERSTANDING

This Amendment (the "**Amendment**") to the Memorandum of Understanding (the "**Agreement**") dated as of may of 2018 is made August 12, 2021 (the "**Effective Date**") by and among:

The Internet Society, a non-profit corporation formed under the laws of the District of Columbia with its principal office at 11710 Plaza America Drive, Suite 400, Reston, Virginia 20190, United States of America ("**ISOC**");

LACNIC is an international non-government organization organized under the laws of Uruguay, with its principal office at Rambla República de México 6125, Montevideo, Uruguay ("**LACNIC**"); and

LAC-IX is an international non-government organization organized under the laws of Uruguay, with its principal office at Rambla República de México 6125, Montevideo, Uruguay ("**LAC-IX**").

The parties hereby agree as follows:

1. **Purpose.** The purpose of this Amendment is to update the annex of the Agreement to accurately reflect the activities and responsibilities of all the parties under the Agreement.
2. **Additional Terms.** This Amendment hereby amends the Agreement by adding Schedule A-1 (the "**Annex**") to the Agreement, which updates the existing annex in the Agreement.
3. **Entire Understanding/Agreement.** Except as otherwise modified by this Amendment, the Agreement remains in full force and effect and forms an integral part of this Amendment. The provisions contained in this Amendment contain the entire agreement between the parties with respect to the subject matter hereof and supersedes all previous agreements or arrangements between the parties relating to such subject matter. No amendment, termination, waiver or discharge of this Amendment or any provision hereof shall be binding unless in writing and signed by the authorized representatives of the parties hereto.

4. **Interpretation and Construction.** In the event of any conflict between the terms and conditions of this Amendment and those of the Agreement, this Amendment shall govern.
5. **Definitions.** All capitalized terms used in this Amendment are defined as set forth in this Amendment, and if not defined in this Amendment, as defined in the Agreement.
6. **Counterparts.** This Amendment may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. This Amendment may be executed in writing with the Amendment in .pdf format or facsimile and the same will be binding upon the executing party to the same extent as the original executed pages. Upon request, the executing parties shall provide originals of the .pdf or facsimile execution pages for insertion into this Amendment in place of the .pdf or facsimile pages.
