Acceptable Uses of Bulk Queries to LACNIC's RDAP

Bulk queries to LACNIC's RDAP may only be used for technical research and/or Internet operation purposes, such as security software design and development, projects for improving Internet performance, and web traffic optimization. They may not be used for publicity, direct marketing, market research, or other similar purposes. The use of information contained in LACNIC's RDAP for these purposes is expressly prohibited, and shall entitle LACNIC to discontinue the requesting party's access to information and initiate the corresponding legal actions. LACNIC requests to be notified in case of proven or suspected misuse of the RDAP.

Redistribution or retransmission of the information by any means is expressly forbidden. Any applicant intending to publish all or part of the supplied information must request LACNIC's prior written consent.

This application form shall be governed by and interpreted in accordance with the laws of the Republic of Uruguay. In case of differences, disagreements or controversies between the parties arising from this contract, said parties shall attempt to solve them by conciliation through the Center for Conciliation and Arbitrage of the Uruguayan Stock Exchange (Centro de Conciliación y Arbitraje de la Cámara de Comercio del Uruguay), according to the regulations contained in said Center's Conciliation Code. Should this conciliation fail, these differences, disagreements or disputes shall be definitely solved through arbitration. The arbitrators shall be three in number and for their designation, as well as for the arbitration procedure, the regulations contained in the Arbitration Code of the Center shall be observed.
